#### Other Matters.

Hon. Member Sagala Edirisuriya Wishing everyone a blessed and prosperous new beginning. Mr. Chairman, residents informed me by telephone that a land called Hinnakmulla belonging to the Kirimetiwila North Grama Niladhari division is currently being sold by a vendor. Previously, 05 acres of this land were sold. Apparently, there was an agreement that when the next 05 acres were sold, a portion would be given to the council. However, there is a suspicion that now about ½ acre is being divided and sold secretly. There is an accusation that the council is not looking into this. Several people spoke to me asking to take the common portion that the council can get. Let's investigate this and display a notice today itself to stop this activity.

Hon. Chairman Sevomasiri Weeraman Honorable Member, I was informed about this last night. I reject the claim that the council is silent. We will try our best to obtain the maximum possible amount.

Hon. Vice Chairman P.G. Palitha Kumara Honorable Member Sagala made a proposal. When selling these lands, we have continuously had issues with promised portions not being received. We have a similar experience regarding the Shanthi Watta land in Akurugoda. During the sale of that land, the vendor agreed to give a portion of his land to the council. However, we did not receive it. Due to that, we lost 60 perches that we should have received from Shanthi Watta.

Government officials change frequently. Although the officials are new, I know that the new officials are studying the files. The council did not prevent the sale of this land.

The land called Hinnakkammulla did not have proper development at that time. Roads were built by a subsequent government. There was no electricity or water. These should be inherited by

future generations. The needs of today's generation should fulfill a requirement for future generations. Basic infrastructure should be available. Even when the Kadukanna Walawwa garden was sold, there was no common area. Selling half an acre is not appropriate; the council should obtain its due share. When obtaining loans from state banks using land deeds, when the required land extent is insufficient, people get surveyors to falsely show 10 perches as 20 perches to obtain loans and get into trouble. No one shows any of these requirements when they get the opportunity to buy land. At that time, their only goal is to acquire the land. Therefore, Honorable Chairman, we have a responsibility to act as intermediaries and ensure that whenever land is sold, the vendor of that land fulfills these common amenities.

Hon. Chairman Somasiri Weeraman We will not allow such incidents to happen in the present. The relevant subject officer is also handling such matters very efficiently. We have arranged work to follow up on every land sale. The relevant responsibilities have been assigned. When the Veshangoda land was sold, we did not have a right to obtain a land block. However, we took it amicably. When the land approval comes, we say to give us a portion. We will not allow land to be sold haphazardly like that during this time. However, I don't know if there are things being done without our knowledge. There are 17 members. They are spread throughout the authority area. Members have a duty to investigate if land is being sold, subdivided, or roads are being constructed in their respective authority areas. Members should fulfill that duty. If they inform us about such matters, we will intervene. During my time, I have not allowed anyone to subdivide and sell land as they please.

Hon. Member Lasantha Ranasinghe Wishing everyone a blessed and prosperous new beginning. Honorable Chairman, we have an efficient officer, Ms. Lawanya. She is the officer who brings development to the Malimbada Pradeshiya Sabha. In every task, she collects the due portion and carries out the work. If we take the Malimbada authority area, the coconut lands are mostly in the Sultanagoda Kotimawa area. Now, all that is being systematically managed. I mentioned Manamperi Watta before. Now, a land being sold under the name Lake Side is progressing. There was a good coconut land. That land has now become barren. Seven acres were sold. There is information that plans are being prepared to sell the remaining 07 acres as well. Those people secretly destroyed the coconut cultivation. A large project was undertaken to plant coconut trees by the Honorable Minister Navin Dissanayake's time, spending millions. All that was pushed aside, and that matter happened. All that is now over. With much effort and in an environmentally friendly manner as we envisioned, that project was carried out with the intervention

**Hon. Member Yohan Samanatha Nadakanda** Wishing everyone a blessed and prosperous new beginning. We are currently developing the road from Udalaththa to Kirimetiwila, which is the Udalaththa Pansala Road, to make it wider. There is a large Imbul tree there, near the Udalaththa fair. We spoke with the RDA, and they said to cut down and remove the Imbul tree. I propose that the council intervene and cut down and remove it.

Previously, a proposal was made to cut down and remove the branches of trees that have fallen onto the Adhikariwila Community Hall and to repair the broken roof tiles of the hall. In this regard, I have another proposal: if possible, we should hire someone to cut down trees for the council. Because we always have to rely on those who cut down trees.

Similarly, we are currently facing a slight inconvenience in maintaining streetlights. Therefore, I request that those items be brought and the work expedited as soon as possible. Thank you.

**Hon. Member Bandula Dikmadugoda** Honorable Chairman, in the Kandashena section of the Korahilagoda Estate in the Akurassa area, rubber is being tapped in the Alnariya line. To transport this rubber, a backhoe is being used to cut roads, and through these improper roads, damage is being caused to people's cultivation and property. The Estate Authority has taken no action in this regard so far. First, the lower part was cut, and now the upper part is being cut. Due to this, a large number of people have been inconvenienced. Therefore, I request you to inform the Estate Authority and take appropriate action.

Hon. Member Rachintha Mohotti Wishing the Chairman and everyone a blessed new beginning. Honorable Chairman, I am speaking about a road in the authority area that is deteriorating. The Nage Kanda Mula Road is used daily by a large number of vehicles and a large number of people to access Horagoda, and it is more used by people than the main Horagoda road. This is a road that was improved by allocating a large sum of money for the previously existing footpath. The Malimbada Pradeshiya Sabha intervened. It can be said to be a road completed with a very successful outcome in the authority area. However, today, those who travel frequently see that the road is deteriorating day by day. Because the drainage system of the road is completely blocked. After the road was constructed, during the heavy rains, water collected. Due to this, in all the places where water could flow into the houses on both sides of the road, no water outlets were installed. Due to this, after the construction, the drains have become blocked everywhere, and mud has washed down from the hills, causing mudslides in many places. Children from distant areas in the Horagoda and Welivahana areas come to the Royal College and the Technical Central College and pass through there. According to the request of these residents, a JCB machine was used to improve it to some extent. However, that is not a proper solution. I request the Honorable Chairman to advise them to install culverts in the places where access to houses is blocked, to repair the drainage system, and to arrange a plan to protect this road. Also, the irregular cultivation work in the land called Nakandagoda is causing soil erosion and landslides into the paddy fields. No notification has been given to the landowners regarding this. I request that technical officers and relevant officers be sent to repair that road very quickly and to arrange a plan to protect it without allowing it to deteriorate further.

**Hon. Chairman Somasiri Weeraman** Following the request of the people, we cleared a drain. I will send a machine to continue clearing along that road. Let's intervene and do that. Let's allocate funds for approximately one kilometer of work. Until then, let's clear the drain.

Hon. Member Peramunage Ajith Nalaka I have only two points to make. This is not a matter belonging to the council. However, it is something that needs to be brought to attention. When the RDA or PRDA improved the Kadduwa main road, they laid ABC and widened the road from Kadduwa junction to Muththettumulla. After that improvement, that road has now become so difficult that it is even impossible to walk on. About 14 buses operate daily. This is a major road from Kadduwa to Mathara. Also, near the Malpiyali house in Katuwangoda, the shoulders of the road have eroded. People are falling down there. A large number of bikes have also fallen. This brings disrepute to our government. I request you to inform the relevant sections to restore these two places to their original condition.

**Hon. Member Suman Dedenipitiyage** Wishing everyone a new beginning filled with peace, happiness, prosperity, a stable economy with no high costs, and low prices for goods.

Honorable Chairman, I inquired about the Cooperative Center. There is a rumor circulating that the Kirimetiwila Cooperative Center is being planned to be brought back to Malimbada. Several villagers inquired about this. We are grateful to the Honorable Mahinda Yapa Abeywardena for providing this Cooperative Center to Kirimetiwila. When there was an attempt to establish an agricultural department's sound station, the then Honorable Minister of Finance, Mangala Samaraweera, stopped it. Currently, the work of the Cooperative Center is being carried out in the Dharma Hall of the Sri Wardhanarama Temple. The Venerable monks are giving their full support without any hindrance. I don't know if there are plans to bring the Cooperative Center to Malimbada when the building of the Divisional Secretariat is completed and those works are finished. I need to ask the Chairman and find out. As this is a region with a dense population, it would be best if that Cooperative Center remained at the Kirimetiwila junction. There is no suitable place near the Kirimetiwila junction within this Kotimawa area for holding urgent Montessori festivals or urgent meetings. Therefore, Honorable Chairman, if there are plans to bring it here, please don't. Currently, the swan building of the Cooperative Center has been built along with a meeting hall. I request that the government allocate some funds to build it properly in Kirimetiwila.

After the Chairman's vote of thanks, the council's work was adjourned at approximately 3:30 p.m.
